INVESTMENT IN INFRASTRUCTURE

In order to sustain the growth of our client-base, product/service offerings, and performance needs, we invested earnings and time in upgrading HIN's equipment and moving to a new data center. Because of this investment, we've seen:

- Over 300% increase in the speed of information availability for HIN users
- Improved storage and networking capabilities across the HIN platform



EXPANSION OF SERVICES & PRODUCTS

Providing products and services that meet and exceed the expectations of our clients is incredibly important to our mission at HealthInfoNet. In 2018 we:

- Developed and deployed a new product called TermAtlas[®] that synthesizes varied terminology in EHRs to a common language
- Secured funding to convene stakeholders and expand our data intake capabilities for social determinants of health and substance use disorder
- Enhanced our notification tool abilities to allow for easier tracking of high-risk patients
