Behavioral Health Home & Opioid Health Home Programs Overview

Making connections to improve patient care, quality, and safety by providing better, easier, and safer solutions.



Top Behavioral Health Use Cases & Interventions

Adapting and advancing as clinical workflows and needs change across the care continuum through applications of timely and actionable information.

Targeted Care Management Services

- Coach clients in avoiding unnecessary Emergency Department (ED) admissions, hospitalizations, and re-admissions
- Proactively identify warning signs and assess risk for re-admissions
- Proactively schedule PCP appointments to avoid ED admissions when warning signs of readmissions are presented

2 Hospital Support

 Assist hospital/PCP nurse care managers through review of ED/hospital discharge plans and make further treatment recommendations as needed

3 Locate "Missing" Clients

• Find clients in the ED or hospital, or identify where else they may be located



4 Comprehensive Transitional Care

- Review post-acute care plans within 24 hours of ED or hospital admission notifications
- Provide same-day services on date of discharge from the ED or hospital following notifications
- Ensure discharge plan medications, services, and equipment are in place and properly utilized
- Schedule follow-up medical appointments with PCP
- Review medication lists and discharge instructions with clients to ensure they are informed of their role in the plan of care
- Communicate plans of care with the medical home
- Advocate for resources and follow-up care for marginalized clients

5 Identify and Coordinate with Client's Care Team

 Identify the multiple medical providers treating the behavioral health client and address duplicate/coordinated care

6 Conduct Medication Reconciliation

 Review MaineCare and pharmacy fill/pick-up medication histories to address discrepancies, duplicate prescriptions, unnecessary medications, and/or inappropriate dosing levels

Intervene with Client Post-Medical Event

- Help clients better recollect medical events and debrief on causes
- Clarify why providers ordered multiple lab tests
- Further ensure clients' compliance with treatment



8 Engage and Educate Clients

- Teach high-utilizing clients about alternatives to the ED
- Help clients use data to get better, make better decisions, and take ownership of their care
- Coach clients on self-management of chronic diseases, with referrals to appropriate resources
- Inform clients about lab results and provide appropriate education to improve wellness
- Review clients' health histories and help interpret medical terminologies to increase clients' understanding, leading to increased control of self-care and reducing the clients' anxieties about medical conditions



9 Assess Accuracy of SMI vs Medical Diagnoses

• Ensure clients are receiving the right diagnosis in order for them to receive the right treatment

10 Identify Gaps/Overuse of Medical Care

- Ensure duplicate labs are not ordered
- Advocate for clients when further care is needed from a PCP or specialist
- Look for gaps in care and ensure things are happening when they need to happen
