

Electronic Health Record Systems

Giving participating providers the ability to securely look up and retrieve real-time health record information in a view-only screen at the point of care to improve individual safety and care coordination activities among treating providers. Access options include a web-based platform (**Clinical Portal**) and an EHR-embedded application (**HINcontext Application**).


Intelligent e-Notifications

Clinical Portal


A web-based platform that provides end users with a robust toolkit to make their workflows more efficient and care coordination activities more seamless.

HINcontext Application

A SMART on FHIR EHR-certified application embedded within customers' clinical workflows with the objective of returning and displaying HIE information most conveniently at the point-of-care.

Custom EHR Integrations

Other integration methods are possible upon customer request, including SAML, PBL, and other available standards.



Intelligent e-Notifications

Our notification services provide real-time alerting of time-sensitive events that make it possible for care managers and other providers to intervene early and establish the right care plan for follow-on action.

My Patients

Manual or automated creation of user-specific patient panels for monitoring specific medical events across defined patient populations.

My Subscriptions

Key medical events, including those required by the CMS Conditions of Participation e-notification rule, that users can receive notifications on for their defined patient panels in real-time or in daily-summary reports.

My Compliance Reports

Detailed compliance audit reports that track to whom and when specific notifications were sent and if their delivery were successful.

- Patient is discharged from skilled nursing facility
- New document is available for patient
- Final radiology report is available for patient
- Final laboratory result is available for patient
- New COVID-19 laboratory result is available for patient
- Interim microbiology result is available for patient
- Final microbiology result is available for patient
- Patient has been reported deceased
