Release Overview

1. Upgrade of reporting server infrastructure and update of Tableau software
2. Performance tuning of backend and frontend systems

4. Modifications to frontend use cases and workflows

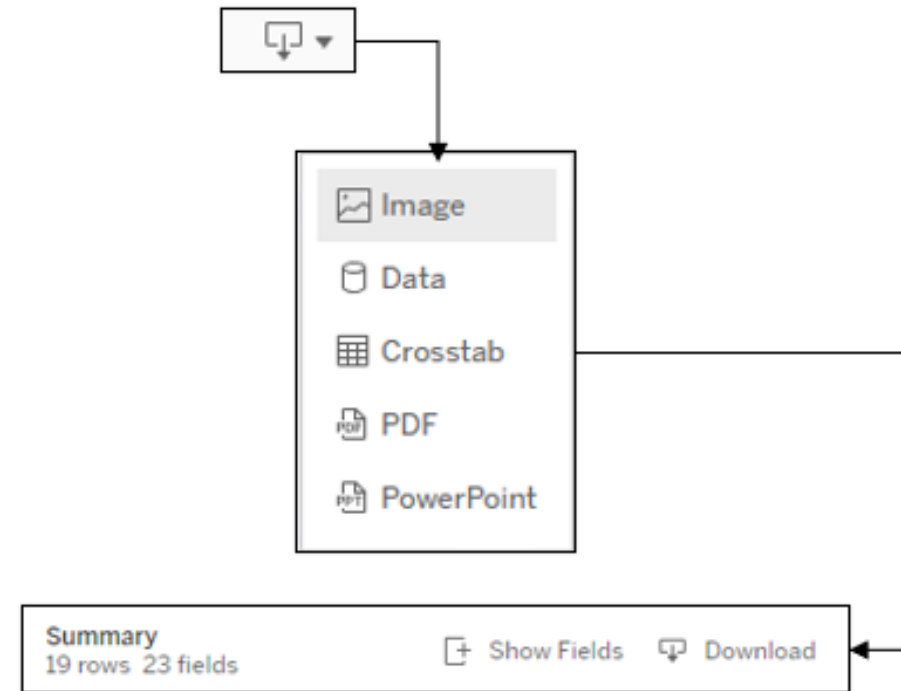




Infrastructure & Software Enhancements

Performance Tuning

Identifying upcoming enhancements, improvements, and/or changes to the service.

- As the service has gained new features, functionality, and use cases since its initial release, the backend and frontend systems have been re-tuned and optimized to ensure continued performance
- Users should experience more performant reporting dashboards, including faster load times of dashboard rendering, filter queries, and data exports





Accessibility Features

Identifying upcoming enhancements, improvements, and/or changes to the service.

Feature	Description
Screen Dimensions	Static screen-size dimensions of 1280 x 720.
Font Color Contrast	Contrast ratio of at least 4.5:1 for normal text and 3:1 for large text.
Object Color Palette Contrast	Contrast ratio of at least 3:1 for graphics and user interface components.
Object Titling	Headers and labels, when available, are clear and descriptive and use a differentiating font size and thickness.
Multi-Select Filter Configuration	List and drop-down filters are implemented instead of dynamic and action filters (with the exception of date range filters).
Data Download Availability	Underlying data sets used within the frontend are accessible for download and offline use.





Use Case & Workflow Modifications

Identifying upcoming enhancements, improvements, and/or changes to the service.

- Redesigned look-and-feel of reporting dashboards aligned with performance tuning, accessibility features, and known use cases and workflows
- Creation of new Insights reporting dashboard; removal of Utilization Map and User Organization reporting dashboards
- Modifications to terminology consistent with participant use cases (e.g., “Utilization” → “Encounter”, “Readmission/Return” → “Readmission”, etc.)
- Simplification of filter options
- Revisions to frontend and exportable tabular views (e.g., add/remove fields, re-order fields)

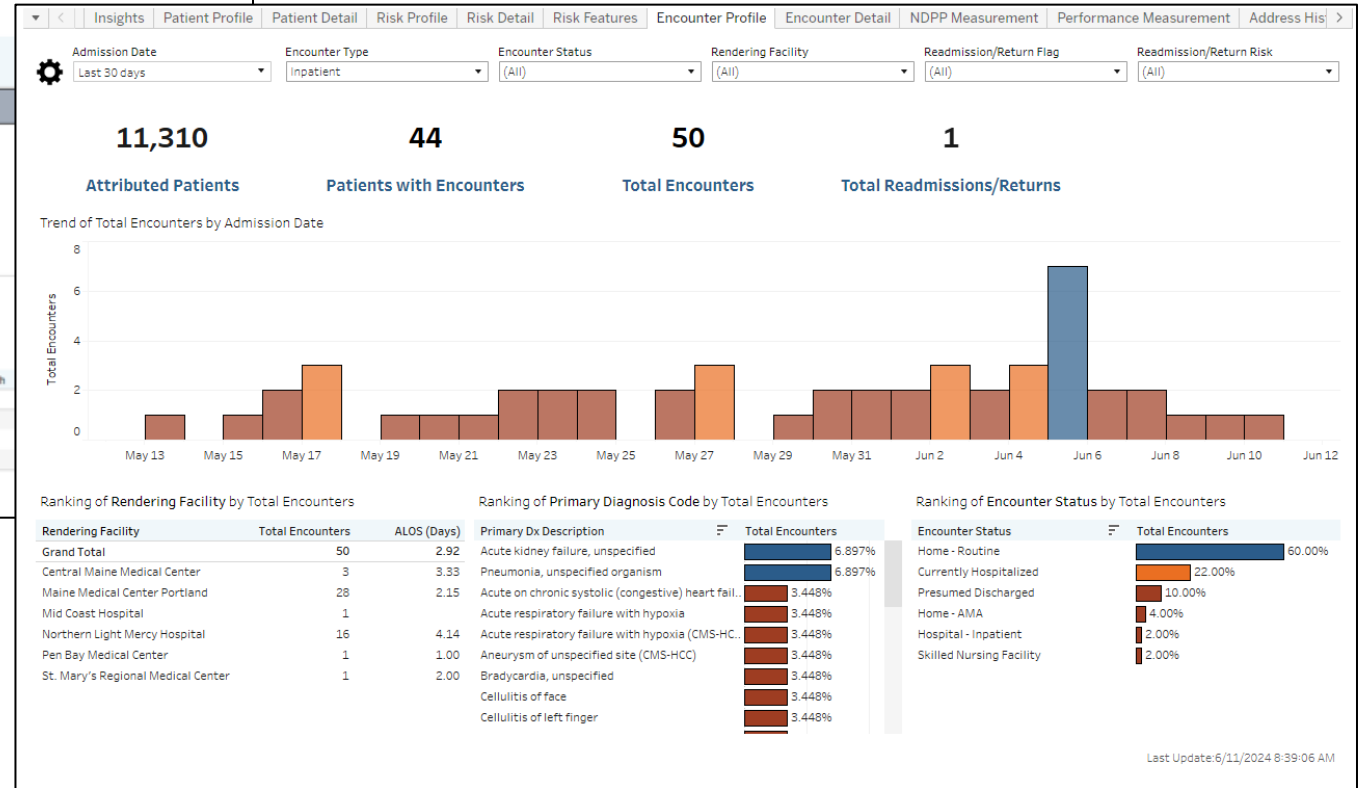
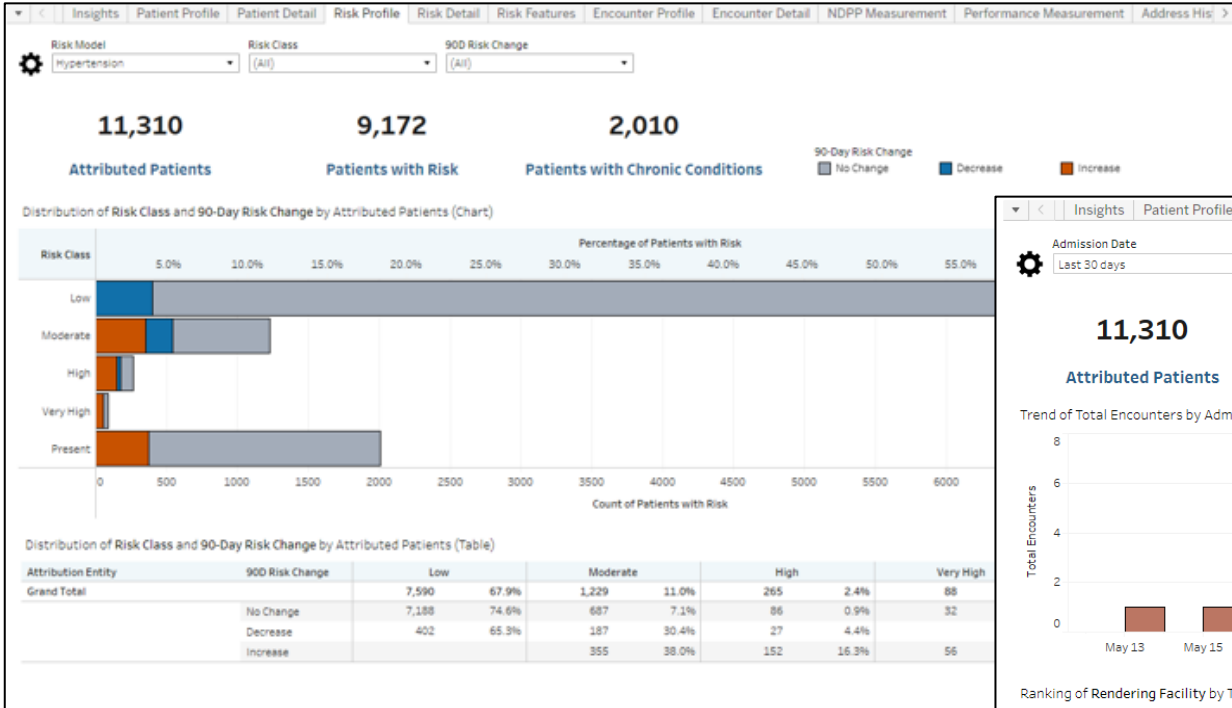

Phase 1 Release Review

A recap of prior and upcoming release events.

July 16: First phase release of HARP v.3.0 implemented for all users.

Users obtain access to HARP v.3.0 for the first time; existing access to HARP v.2.0 (i.e., the current service version) is retained. All access is maintained on the current HARP reporting server

- Users should continue to perform their work in HARP v.2.0
- Users should begin to preview HARP v.3.0 to ensure it meets their use case and workflow needs
- Users should take note of their **saved reporting dashboard configurations** in HARP v.2.0 in anticipation of the second phase release on **July 30**
- Users should not yet create new saved reporting dashboard configurations in HARP v.3.0

Phase 2 Release Review

A recap of prior and upcoming release events.

July 30: Second phase release of HARP v.3.0 implemented for all users

Users' access to HARP v.2.0 and HARP v.3.0 will be migrated from the current HARP reporting server to the new HARP reporting server

- Users' previously **saved reporting dashboard configurations in HARP v.2.0 will be lost**
- Users should begin to transition their work from HARP v.2.0 to HARP v.3.0
- Users should only **create new saved reporting dashboard configurations in HARP v.3.0 ongoing**
- Users should take note of the **HARP v.3.0 tabular exports** - and begin to adjust internal processes that leverage them - in anticipation of the third phase release on **August 13**

Phase 3 Release Review

A recap of prior and upcoming release events.

August 13: Third phase release of HARP v.3.0 implemented for all users

Users' access to HARP v.2.0 will be lost

- Users must exclusively perform their work in HARP v.3.0 ongoing
- Users' use of the service's **tabular exports may have changed** from HARP v.2.0 to HARP v.3.0; users must adapt their processes accordingly
